## *Proposed Amendments*

*pg 1 of 4*

### Article III, Section 4.

No act of this organization or section of this constitution or its bylaws may conflict or be construed so as to conflict with the constitution, bylaws, or acts of the National Junior Classical League, the Classical Association of Florida, or the American Classical League.

#### Rationale:

Since the National Junior Classical League and the American Classical League are parent organizations of this organization, and the Classical Association of Florida is the sponsor of this organization, this organization should not be permitted to do anything that conflicts with them.

### Article III, Section 5.

The Board of Advisors shall have the authority to nullify, by unanimous vote, any act of this organization, which it feels will greatly interfere with the legitimate operations of this organization.

#### Rationale:

This amendment would provide a failsafe for the event of this organization passing a resolution that would do more harm than good. It should only be used in *extreme* situations.

### Article IV, Section 3.

Any member-at-large or long distance member of the National Junior Classical League residing in the state of Florida shall become a member-at-large of this organization upon his proper registration.

#### Rationale:

The FJCL Constitution currently makes no provision for long distance members as mentioned in Article IV, Section 1, Part B. This corrects for that by moving such members into the member-at-large group.

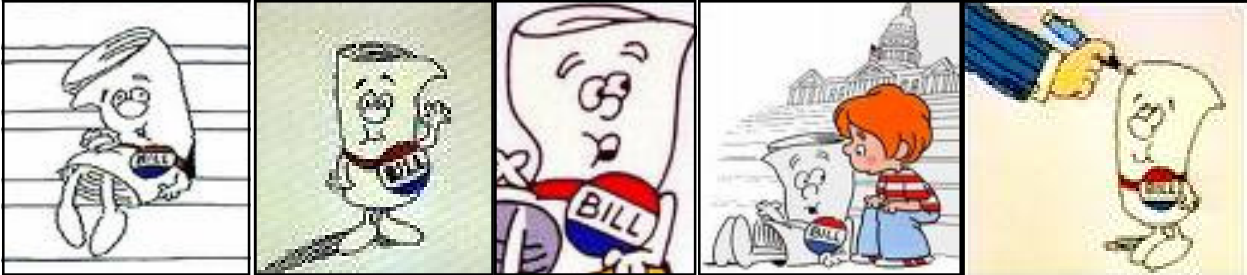

### Article V, Section 4.

No more than two members from the same *school* shall serve as officers of this organization simultaneously.

#### Rationale:

Since all of the members-at-large are considered one chapter this limit leaves them with a disadvantage over regular chapter members. Changing *chapter* to *school* will maintain the limit for everyone and would allow three members-at-large from different schools to run for office, in such a rare event.



### Article V, Section 7.

In order to be eligible for candidacy for an elected office *an individual must be eligible to hold the office for which he intends to run; must be a member of chapter running no more than one other candidate for an elective office; must submit a completed declaration of candidacy form, on which he shall declare the office for which he seeks candidacy, and affirm his eligibility to hold office and intent to serve if elected. This form must be sent by the deadline that shall be set each year by the Executive Board, and must include the signed approval of the individual's parent or legal guardian, sponsor, and school principal.*

#### Rationale:

The first new qualification should be obvious. It has simply been added to this amendment in order to make the constitution as lucid as possible. The second qualification has been added in order to prevent three people from a school from running for office when only two could be constitutionally elected (Article V, Section 4). Article V, Section 4 should remain, however, in order to prevent appointed officers from circumventing the two officer limit.

### Article V, Section 8.

In the event that there are *no* candidates for an elected office by the submission deadline of the declaration of candidacy form, any eligible individual has the right to seek candidacy for that office. In this situation, the procedure shall be as follows: the Parliamentarian, promptly after the close of the opening assembly of the State Latin Forum, shall accept a completed declaration of candidacy form from each eligible individual wishing to be a candidate for that office; the Parliamentarian shall waive the requirements of the original submission deadline and of the signatures of the parent or legal guardian and school principal; *however, the approval of the parent or legal guardian must be assured.*

#### Rationale:

The original provision called for this situation when there were *less than two* pre-filed candidates. This would cause such a situation almost every year in at least one office. The purpose of candidates pre-filing would lose its use. This amendment changes it from *less than two* to *no* pre-filed candidates.

In such a situation, although attaining the notarized signatures of the parents would be nearly impossible, the approval of the parents should still be assured, whether by phone or some other communication. The original provision could allow someone to run for office and then be prevented from serving by the disapproval of the parents. This amendment provides for the guarantee of the parent's approval.

### Article IX, Section 2.

#### REMOVAL OF SECTION FROM CONST.

~~— A Constitutional Committee composed of the current elected officers, their immediate predecessors, and the Chairman of the Board of Advisors, shall be appointed by the current President promptly after the close of the State Latin Forum. The current President shall serve as the chairman of this committee. The Constitutional Committee shall review this constitution and the bylaws of this organization, and shall propose any necessary amendments to this constitution and the bylaws of this organization to the membership of this organization. The Constitutional Committee shall also be responsible for the maintenance of this constitution and the bylaws of this organization. Meetings of the Constitutional Committee shall be held on an as-needed basis. Meetings may be called by the current President or by the Chairman of the Board of Advisors and shall be called upon the written request of three members of this committee. Except in cases of emergency, at least two weeks' notice shall be given.~~

#### Rationale:

This committee has outlived its use and is far too powerful.

### Article XIII.

#### Suspension of the Constitution and Bylaws

In the case of extreme emergency, any part of this constitution or its bylaws may be suspended by a unanimous vote of the Board of Advisors.

#### Rationale:

Due to the recent problems with the constitution, there should be a way to constitutionally suspend parts of the constitution and bylaws. The word *extreme* should not be downplayed. Since suspending the constitution and bylaws is a huge parliamentary *faux pas*, this Article should be removed after a sufficient time has passed with no constitutional issues.
